MULTI-YEAR BUDGET NARRATIVE and ASSUMPTIONS

The Multi-year Projection is based on the following assumptions:

- The Local Control Funding Formula (LCFF) revenue has been calculated using the FCMAT (Fiscal Crisis and Management Assistance Team) calculator. The calculator was updated by FCMAT based on the Governor's January Proposed 2023 State Budget.
 - ✓ The calculation for the Supplemental/Concentration funding is \$5,182,619 for 2022-23, \$5,133,777 in 2023-24, and \$5,214,910 in 2024-25.

Enrollment/ADA Projections:

- The District is funded on the attendance rate of the enrollment or "Average Daily Attendance" (ADA). Historically pre-pandemic, the District averaged about a 95% - 96% actual attendance rate on enrollment. In 2021-22, the attendance rate was approximately 90%, the COVID-19 pandemic has adversely affected the attendance rate. For 2022-23, the assumption is a return to pre-pandemic attendance rates gradually, as of 22-23 P-1 attendance reporting the District is at 92%.

- Funded ADA is projected to reflect the Governor's Enacted 2022 State Budget to fund ADA on the greater of the actual current year, prior year or an average of the prior 3 years ADA, including the use of the 19-20 attendance yield for the 21-22 ADA determination.
 - 3,329.31, using a 92% attendance rate, greatest ADA is the 3-year average
 - 3,218.45, using a 92% attendance rate, greatest ADA is the 3-year average
 - 3,128.39, using a 92% attendance rate, greatest ADA is prior year

- The Routine Repair and Maintenance restricted account receives the required 3% of the total general fund budgeted expenditures for 2022-23 and beyond, additional contribution is added when various projects will exceed that.
- Budget reductions may be needed in any given year to correct the structural deficit in the Unrestricted General Fund due to the loss of LCFF funding from declining enrollment or other State factors.
- Out years project the spending down of one-time multi-year restricted grant dollars.
- Components of the Ending Balance
 - Restricted carryovers each year must be reserved as part of the program from which the funding originated.
 - Reserve cap triggered in 2022-23 per EC 42127.01, funds were committed to reflect a combined assigned and unassigned ending general fund balance of no more than 10 percent for the Budget year.
 - ✓ Board policy 3100: Board intends to maintain a minimum unassigned fund balance which includes a reserve for economic uncertainties of 9 percent of general fund expenditures and other financing uses.
