D. Reports

LCAP GOAL 1

Develop and Implement Personalized Learning and Strengths-based Growth Plans for Every Learner

1. Race to the Top-District 2017 Power of Partnerships Convening: Cradle to Career

Karen Schauer reported on June 29, 2017, a Galt Regional Leadership Team participated and contributed to advancing partnerships efforts to personalize learning from cradle to career. The team included:

Dr. Schauer indicated the team was invited because GJUESD is one of 16 Race To The Top grant recipients. She indicated it was an honor to listen to the improvement effort stories from other districts throughout the United States as well as share GJUESD efforts.

Dr. Schauer shared a video from the Kentucky Valley Educational Cooperative. She indicated part of their evolving story is to dramatically improve educational outcomes for students in rural schools. They have built strategic partnerships with organizations throughout the United States that contribute to maximizing their efforts.

Dr. Schauer stated that the US Department of Education has taken excerpts and footage from our district along with other districts for national dissemination. Dr. Francis James Dragna, on behalf of CSUS President Robert Nelson, has conveyed commitment to articulate the "GALT" personalization model through college.

Additional information shared at the summit included Cradle to Career Civic infrastructure information to maximize supports and opportunities for every child from the Strive Together organization and information from a variety of funders. Betsy McCarthy, WestEd Senior Researcher, is conducting deeper research to help identify best practices.

Karen Schauer stated that although Galt City Manager Eugene Palazzo could not attend the summit, he is informed about the work the district is doing.

2. Personalized Learning Plan (PLP) Continuous Improvement 2017: Overview and Next Steps

Karen Schauer reported that in order to further improve the PLP for 2017-18 implementation, stakeholder input was used to identify impacts and issues.

Claudia Del Toro-Anguiano stated that the PLP has been refined to a two page document including learner profile and growth and achievement pages.

3. GJUESD Home Study Program Update

Donna Mayo-Whitlock reported that the home study program is a partnership between the school district and parents. She emphasized the program offers a personalized blended learning experience and efforts are being made to promote the program.

1. Facilities and Measure K Projects Update

Tom Barentson reported the next Citizens Oversight Committee will be held on August 14, at Greer Elementary School. A presentation by Derivi Castellanos Architects (DCA) will be given at the August board meeting regarding the process for prioritization of the modernization projects at Greer and Valley Oaks Elementary.

Mr. Barentson added that potential Proposition 51 Modernization funding could increase our modernization fund by over six million dollars. The three eligible schools are Greer, Valley Oaks and River Oaks Elementary.

John Gordon asked when Marengo Ranch Elementary will be eligible for modernization funding.

Tom Barentson stated 5 years approximately.

Tom Barentson stated that the school district budget was approved by the Sacramento County Office of Education (SCOE). He indicated that the budget has changed significantly since it was adopted so a revised budget will be brought back to the Board in August or September.
