

The attached Memorandum of Understanding between CSEA Chapter 362 and the GJUESD assists the District in closing the salary gap for transportation mechanics with the Galt High School District (GHSD). Both the GJUESD and the GHSD are jointly managed.


Memorandum of Understanding
between the
California School Employer's Association Chapter 362 (CSEA Chapter 362)
and the
Galt Joint Union Elementary School District (GJUESD)

CSEA Chapter 362 and the GJUESD agree to the temporary wage adjustment of Josh Little, Mechanic, to Class 23, step E of the Galt Joint Union High School District salary schedule effective October 1, 2015 and ending upon completion of negotiations of salary adjustments for the Mechanic position or June 30, 2016, whichever comes first. In the event that the negotiation process is not completed by June 30, 2016 the temporary adjustment will move automatically to Class 23, step E of the 2016-17 salary schedule of the Galt Joint Union High School District.

CSEA Chapter 362 and the GJUESD also agree to a stipend of \$100.00/month to be paid to Josh Little for providing additional support to the mechanic to be hired to fill an existing vacancy. This stipend shall become effective upon the hire date of the mechanic and end six (6) months after the hire date.
