SUBJECT: 2015-2016 Second Period Interim Report

Dear Superintendent Schauer:

After submission of the Second Period Interim Report, the County Superintendent of Schools is required to review the report for adherence to the State-adopted Criteria and Standards pursuant to Education Code sections 42130-31 and 33127. The district filed a Second Interim Report with a **positive** certification. Based on the multi-year projections and assumptions provided by the district, it appears the district will meet its 3% unrestricted reserve requirement for the current fiscal year and two subsequent fiscal years. We concur with the district's **positive** certification with the following comments:

- The multi-year projections submitted project that the unrestricted General Fund balance will decrease by \$170,220 in 2017-2018.
- The district continues to project fluctuating enrollment and is expecting a decrease of 20 ADA in 2015-2016, 24 ADA in 2016-2017, and an increase of 13 ADA in 2017-2018.

We continue our request that the district provide the following:

• We note that the certificated and classified bargaining units have not settled collective bargaining for the current year. Before the district's board of education takes any action on a proposed collective bargaining agreement, the district must meet the public disclosure requirements of Government Code section 3547.5 and the California Code of Regulations Title V, section 15449. Please submit the public disclosure of the collective bargaining agreement to the county office for review at least ten (10) working days prior to the date the governing board will take action on the proposed



bargaining agreements. This form must also be available to the public at least ten (10) working days prior to the date the governing board will take action on the proposed bargaining agreements. Also, as provided by the State Criteria and Standards, when labor contract negotiations are settled after the adoption of the district's budget, the district must analyze the budget to determine the effect of the settlement, and the governing board must certify to the validity of the analysis within 45 days of the final settlement. Within this 45-day period, the District Superintendent must also send the County Superintendent any revisions to the district's current budget necessary to fulfill the terms of the agreement.

- Notify us immediately, and provide for our review, any changes to the budget.
- Continue to closely monitor future enrollment trends and inform us of budget adjustments should enrollment trends fluctuate.

We would like to thank your staff for their cooperation during our review process.

Why Conduct a Listening Circle?

- Gives students a meaningful opportunity to contribute to school decision-making
- Contributes to positive relationships between students and staff
- Adults learn that students really value adults who listen to them
- Students learn that young people from different backgrounds have very similar perspectives and develop a greater respect for similarities and differences across groups and cultures
- Contributes to improved school climate

Why It Is Important (Potential Benefits)

The reversal of formal roles makes a strong impression on students and adults alike. Youth and adults learn what students really think and have impetus to work in partnership to develop strategies for change.

1. The school community benefits (Izu,2004,2008) from:

- a. A strengthening of adult-student relationships
- b. Improvements in school climate
- c. Action plans and activities that youth feel make a difference
- d. Adults taking responsibility to follow-up on recommendations generated by students (Bernard and Slade, 2009).

2. Adults benefit from:

- a. Discovering that young people value adults who genuinely want to help them.
- b. Learning that students appreciate knowing the "little things" that are within their power to do in order to make a difference in the lives of youth.
- c. Realizing that young people know a great deal about how their schools and communities operate.

3. Students benefit from:

- a. Experiencing a process that embodies the three major protective factors (caring relationships, high expectations and meaningful Participation).
- b. Identifying and making school program and policy changes based on their needs, experiences and interests.
- c. Learning that young people from different backgrounds have very similar perspectives on important questions, and develop a greater respect for similarities and differences across different groups, cliques and even gangs.

What It Requires of Adults Who Participate

- 1. about 3.5—4 hours of your time
- 2. Adults who are willing to listen to and support students

Overview of the Listening Circle Process

Purpose

- 1. Provide an opportunity for student voices to be heard.
- 2. Provide an opportunity for students, staff, and parents to improve their school climate.
- 3. Give richer meaning to the GJUESD LCAP Goals

What It Is?

A three part focus group process that examines positive caring relationships, high expectations, meaningful participation, and other areas of improving school climate.

Welcome/Introduction (15 minutes)

Part 1. Adult Orientation (45 minutes)

- a. Review the importance of a positive school climate
- b. Review the high expectations, caring relationships, and meaningful participation at the school.
- c. Discuss the importance of listening to students.
- d. Review the Listening Circle process

Part 1. Student Orientation (45 minutes)

- a. Making students feel comfortable with speaking out
- b. Explaining the purpose of the listening circle is to uncover what adults can do to strengthen students' connection to school
- c. Clearly describing the process
- d. Clearly describing the student agreements
- e. Writing answers to the questions
- f. Practice reframing complaints, criticism, and negative comments as positive examples, ideas, and suggestions

Part 2- Listening Circle: Youth Speak and Adults Listen (60 minutes)

- a. A group of 6-8 students representative of the school sit in a tight circle with a facilitator.
- b. Youth respond to a set of 4-6 questions with one youth at a time answering the same question.
- c. A group of 12 –16 adults sit in a larger circle around the students.
- d. Adults listen.

Part 3- Dialogue (60 minutes)

- a. Everyone moves his or her chair to form one large circle.
- b. Two volunteers (one adult and one student) take notes on chart paper
- c. Discuss main ideas, themes, key points, concerns, recommendations, action items and those responsible.

Student Agreements

- Turn off cell phone and refrain from texting.
- Focus on what you do like, want, or need (not on what you don't).
- Only use people's names when making positive comments.
- Be respectful of each other.
- Pay attention to the timekeeper.
- · Speak your truth!

Adult Agreements

- Turn off cell phone and refrain from texting.
- Stay for the entire listening circle.
- Be silent during the student voice (response) portion, i.e. listen attentively.
- Commit to a plan of action that reflects the students' perspectives.

Questions that students will be answering...

- 1. Every student at your school has a personalized learning plan with goals. How can we support you to help you achieve your personal learning goals and future dreams?
- 2. At your school there are different opportunities to learn and grow, like using technology, the Bright Future Learning Center, ASES and service learning projects. What other things would you like to see in those programs?
 - Follow-up question: What other opportunities would you like to see in school? How could the school building look or be changed to help you with your goals for the future?
- 3. Would you like to have more choice in what you are being taught? How would you like to be included in making decisions about what you are learning?
- 4. Do you have dreams and ideas about your future in school? How do your teachers support your hopes for the future?
- 5. What is the BEST thing about Greer? If you could help change one thing to make it better, what would you change?

D. Communications

 Donna Whitlock shared a communication from Sacramento County Office of Education regarding Fairsite School Readiness Center- State Preschool Program Supplemental Block Grant.

E. Reports

Curriculum Director

- 1. Students from Ms. McCown's 3rd grade class at River Oaks Elementary presented information on a project-based Service Learning project they completed. The project involved making fleece blankets for children at Shriners Hospital. The student presenters were: Alina Hurtado, Nathaniel Edwards, Lucas Temple, Holly Lozano, and Izabella Cathey.
- 2. Ron Rammer reported on Middle School Teaming and Career Tech Education Incentive Grant (CTEIG).
 - Mr. Rammer reported that school teaming provides a more personalized learning experience for students based on an improved understanding of the students and their specific learning needs. Teams will be built around the core-subject-area teachers in English language arts, math, science, and social studies. Additionally, guidance counselors, special-education teachers, and other specialists will be assigned to teams. The teams will consist of approximately 150 students.
 - Mr. Rammer reported that the Career Tech Education Incentive Grant received by Galt High School District could provide pathway classes and programs to middle school students through exploratory. In addition, the grant could create a working farm on the 10 acres adjacent to McCaffrey Middle School.

Superintendent and Business Services Director

- Karen Schauer reported on LCAP Goal 4: 21st Century Facilities for High Level Instruction. She indicated the district is preparing and researching a possible November General Obligation Bond based on Board of Trustees direction to keep moving forward with GJUESD Bright Future Learning mission and vision by prioritizing District needs and further engaging the community.
 - Dr. Schauer and Addison Covert, Attorney, shared information on the publication: District Activities Relating to Dissemination of Information and Use of Funds for a General Obligation Bond Measure. She indicated the District is considering strategic methods to engage the community such as school presentations at School Open Houses, Back To School Nights, and reaching out to service organizations.
- 2. Karen Schauer shared information on the Eastview Development Project and New Elementary School Efforts and Challenges. She indicated that a new housing development is being considered in Galt. She has presented information to the City

Planning Commission regarding costs and safety concerns in planning for a new elementary school. Upcoming City Council meetings are Mar. 25th, Apr. 5th and Apr. 19th.

Tom Barentson indicated that the District has been a proactive, positive partner with the City and expressed a need to inform stakeholders of the costs of a new elementary school.

Addison Covert provided information on funding sources for school facilities, including developer fees, state of CA funding, and other entities. He indicated the importance of all funding sources working together for maximum effectiveness.

John Gordon stated that it is important for the community to understand that the Board does not want new school construction to burden existing land owners.

Educational Services Director

- 1. Robert Nacario reported on Public Safety Training Institute on March 8, 2016: School Violence & the Active Shooter. He indicated that the Superintendent, Administrators, Supervisors and After-School Coordinators participated in this safety training. The training focused on studies that have been done on recent school incidents to determine best practices for schools in an emergency. Exercises included safety flipcharts for all schools, refining school emergency plans and sharing best practices with parents. In addition, the training including information on defensive classrooms and buildings to consider.
- 2. Robert Nacario reported on Technology Infrastructure and Ray Morgan Company Network Assessment. He indicated that our district is fortunate to have a partnership with Sacramento Educational Cable Consortium (SECC) as it pays for half of what the bandwidth increase would cost through a federal grant. He stated that Ray Morgan will do a Network Assessment after Elk Grove Unified updates their network technology as our network technology is dependent on Elk Grove completing their upgrades since the fiber optic cable lines come from Sacramento through Elk Grove to Galt.

Willie Marlin addressed the board regarding internet access concerns. He indicated that the issue was with an outside source serving our area and the issue has been resolved.

John Gordon requested to add technology to pending agenda items.

Business Services Director

- Tom Barentson provided a Public Agency Retirement Services (PARS)
 Supplementary Retirement Plan for Certificated Non-Management Employees Update.
 He indicated that the District will meet the minimum number of retirees needed to offer this plan.

Given the upcoming June 2016 retirement of Robert Nacario, Director of Educational Services, the superintendent is 1) striving for an efficient and strategic leadership transition while 2) sustaining school level administration and 3.) providing more administrative support to special education.

To accomplish this, the district office administrative staffing would be restructured to

- 1. Eliminate the Prevention and Intervention Coordinator administrative position
- 2. Redistribute some district administrative roles between Director of Curriculum, Director of Business, new Director of Educational Services and Coordinator of Instructional Technology Integration and Innovation.
- 3. Appoint Donna Whitlock (current Prevention and Intervention Coordinator) to Director of Educational Services.
- Return special education services to the Educational Service Department.
 Jamie Hughes, Coordinator, would include administration duties for special education services.

Donna Whitlock has served in GJUESD for 24 years, with a broad range of Pre-k-12 leadership experience in state and federal programs, special education implementation, grantsmanship and policy development. Jamie Hughes has served as a GJUESD regular education teacher, special education teacher and academic coach.

The appointment of Donna Whitlock to Director of Educational Services is recommended to support the upcoming leadership transition and district level administration restructuring. The start date is June 1, 2016. The savings for the elimination of the Prevention and intervention Coordinator is approximately \$125,000 that includes salary and benefits.

On February 24, 2016 the School Board approved the PARS Supplemental Retirement Plan for Certificated Non-Management employees.

A Meeting with eligible employees on February 25, 2016 @ McCaffrey Middle School. 26 staff members attended to hear representatives from PARS explain the plan, give examples, and the timeline for their application. Each attendee received a packet that contained their individualized plan information based on their age, years of STRS service, and salary history. Those who did not attend had their packets sent to their home on February 26th. Staff had until April 8th to make their decision. On April 6th a second meeting was held in the Conference Room at the District Office.

On April 8, 2016 ten (10) eligible non-management certificated completed their paperwork and signed their intent to retire from the District and to participate in the plan, provided that the PARS analysis of the information indicated that the District would meet their financial goals for the process and achieve financial savings that would make this program possible.

Based on PARS and District analysis, we are projecting savings of \$127,944 in the first year and \$445,494 over a 5 year period. (savings realized when replacing all retirees)



Please do not make any travel plans or reservations before you have been accepted to the institute.

PAYMENT METHODS AND DEADLINES

The institutes may be paid for by credit card, debit card, or purchase order (NYC DOE applicants may submit a signed work order until purchase orders for 2017 are available). Payment is due within 14 days of your acceptance. You will receive a reminder message before the payment deadline expires. Requests for exceptions to this deadline must be submitted in writing to contact@readingandwritingproject.com before the 14 day period is over, and will be considered on a case-by-case basis. While we try to make accommodations whenever necessary, we reserve the right to withdraw applications if payment has not been made on time. Accepted applicants who withdraw may be charged a fee.

INSTITUTE FEES

The noncredit fee for 2016 summer institutes is \$825 (\$775 plus a \$50 materials fee) per person, per institute.*

* This includes a \$75 non-refundable application and processing fee. That is, if you have been accepted to an institute and confirm that you plan to attend, by paying for the institute, and then you later withdraw before the withdrawal deadline, you will still be responsible for the \$75. However, if you withdraw from the institute after May 6 (for institutes in June) or May 27 (for institutes in August), you forfeit your entire fee. Instructions for making such a request will be included in your acceptance email. These fees are for non-graduate credit only. To apply for graduate credit, please see fees and other information below.

APPLYING FOR GRADUATE CREDIT

Institutes are offered for graduate credit through Teachers College at a cost of \$1,454 per credit. All graduate credit participants must also pay a special course fee of \$70. First year and advanced applicants may apply for graduate credit. Once you apply (or are accepted) on a noncredit basis, you may not change your enrollment to credit (or vice versa); if you want to switch your application, you must withdraw and reapply.

If you are not currently enrolled in a degree program at TC, you will need to complete a non-degree application online and submit proof of baccalaureate (a photo-copy is acceptable). You are also required to submit a non-refundable application fee (\$65 for new applicants and \$35 for re-applicants).

The course numbers are: C&T 4858 (Reading), C&T 5800 (Writing), and C&T 5850 (Reading/Writing Connections; prerequisite C&T 4858 and/or 5800). All institutes can be taken for 3 credits; the writing institutes can also be taken for 6 credits and the August institutes can be taken for 1 credit. The institute courses are pass/fail. A limited number of students can attend each section/institute.



SCHOLARSHIPS

A few scholarship opportunities are available for this year's summer institutes. These include: the **David M. Price Memorial Scholarship Fund**, which will offer a scholarship for tuition to one of our August institutes for one upper grade participant; **The Booksource Scholarship**, which will offer two \$1,250 scholarships and classroom libraries (one for a reading institute participant and one for a writing institute participant); and the **Growing Teachers Grant**, which will grant \$2,000 for one primary participant to attend either the June or August Reading Institute. Public health nurses, Early Head Start teachers, family therapists, maternal-child nurses, social workers, doulas, and home visitors have all attended the training and incorporated the research and interventions into their work with pregnant women, assisting them to move beyond the physical dimensions of pregnancy to the emotional and psychological challenges new parents experience.

Dr. Virginia Buccola-Tournay is a Family Psychiatric Mental Health Nurse Practitioner and Infant Mental Health Specialist at Greater Lakes Mental Health Care and in private practice in Tacoma, WA. Virginia has many years of registered nursing experience in Community Health, Maternal-Child Health, Lactation Support and Adult Inpatient Mental Health. Professionals are often well trained and equipped to help women deal with the physical aspects of pregnancy.
