# Trustee Area 1:

Beginning at the intersection of Highway 99 and the District southern boundary; then proceeding northerly along Highway 99 to Woodson Rd; then proceeding northwesterly along Woodson Rd to Lower Sacramento Rd; then proceeding northerly along Lower Sacramento Rd to Dry Creek; then proceeding westerly along Dry Creek to the Southern Pacific Railroad; then proceeding northerly along the Southern Pacific Railroad to Kost Rd; then proceeding easterly along Kost Rd to Joy Dr; then proceeding northerly along Joy Dr to the southern edge of parcel APN 15003710210000; then proceeding east along the parcel lines to Lincoln Way; then proceeding northerly along Lincoln Way to Southdale Ct; then proceeding easterly then northerly along Southdale Ct to Meladee Ln; then proceeding northeasterly along Meladee Ln to Glendale Ave; then proceeding easterly along Glendale Ave to Fairway Dr; then proceeding northerly along Fairway Dr to A St; then proceeding easterly along A St to Highway 99; then proceeding northerly along Highway 99 to Simmerhorn Rd; then proceeding southwesterly along Simmerhorn Rd to Lincoln Way; then proceeding southerly along Lincoln Way to A St; then proceeding westerly along A St to S Emerald Oak Dr; then proceeding southerly along S Emerald Oak Dr to C St; then proceeding westerly along C St to Range Way; then proceeding southerly along Range Way to E St; then proceeding easterly along E St to Village Run Dr; then proceeding southerly along Village Run Dr to New Hope Rd; then proceeding westerly along New Hope Rd to Orr Rd; then proceeding southerly along Orr Rd to New Hope Rd / Kost Rd and continuing southerly to Dry Creek; then proceeding westerly along Dry Creek to the western boundary of the District; then proceeding counter-clockwise along the District border to the point of beginning.

#### Trustee Area 2:

Beginning at the intersection of Lincoln Way and Elm Ave; then proceeding southerly along Lincoln Way to A St; then proceeding westerly along A St to S Emerald Oak Dr; then proceeding southerly along S Emerald Oak Dr to C St; then proceeding westerly along C St to Range Way; then proceeding southerly along Range Way to E St; then proceeding easterly along E St to Village Run Dr; then proceeding southerly along Village Run Dr to New Hope Rd; then proceeding westerly along New Hope Rd to Valley Tree Rd; then proceeding northerly along Valley Tree Rd to Orr Rd; then proceeding easterly along Orr Rd and continuing easterly along Elm Ave to the point of beginning.

# Trustee Area 3:

Beginning at the intersection of Highway 99 and the District southern boundary; then proceeding northerly along Highway 99 to Woodson Rd; then proceeding northwesterly along Woodson Rd to Lower Sacramento Rd; then proceeding northerly along Lower Sacramento Rd to Dry Creek; then proceeding westerly along Dry Creek to the Southern Pacific Railroad; then proceeding northerly along the Southern Pacific Railroad to Kost Rd; then proceeding easterly along Kost Rd to Joy Dr; then proceeding northerly along Joy Dr to the southern edge of parcel APN 15003710210000; then proceeding east along the parcel lines to Lincoln Way; then proceeding northerly along Lincoln Way to Southdale Ct; then proceeding easterly then northerly along Southdale Ct to Meladee Ln; then proceeding northeasterly along Meladee Ln to Glendale Ave; then proceeding easterly along Glendale Ave to Fairway Dr; then proceeding northerly along Fairway Dr to A St; then proceeding easterly along A St to Highway 99; then proceeding northerly along Highway 99 to Southern Pacific Railroad; then proceeding northeasterly along Southern Pacific Railroad to Marengo Rd; then proceeding northerly along Marengo Rd to Elk Hills Dr; then proceeding westerly along Elk Hills Dr to Walnut Ave; then proceeding northerly along Walnut Ave to Park Terrace Dr; then proceeding northerly along Park

Terrace Dr to Twin Cities Rd; then proceeding westerly along Twin Cities Rd to Mckenzie Rd; then proceeding northerly along Mckenzie Rd to the northern boundary of the District; then proceeding clockwise along the District border to the point of beginning.

## **Trustee Area 4:**

Beginning at the intersection of Mckenzie Rd and the District northern boundary; then proceeding southerly along Mckenzie Rd to Twin Cities Rd; then proceeding easterly along Twin Cities Rd to Carillion Blvd; then proceeding southerly along Carillion Blvd to Walnut Ave; then proceeding westerly along Walnut Ave to Stockton Blvd; then proceeding southerly along Stockton Blvd and continuing southerly along Highway 99 to Simmerhorn Rd; then proceeding southwesterly along Simmerhorn Rd to Lincoln Way; then proceeding southerly along Lincoln Way to Elm Ave; then proceeding westerly along Elm Ave and continuing westerly along Orr Rd to Valley Tree Rd; then proceeding southerly along Valley Tree Rd to New Hope Rd; then proceeding westerly along New Hope Rd to Orr Rd; then proceeding southerly along Orr Rd to New Hope Rd / Kost Rd and continuing southerly to Dry Creek; then proceeding westerly along Dry Creek to the western boundary of the District; then proceeding clockwise along the District border to the point of beginning.

# **Trustee Area 5:**

Beginning at the intersection of Twin Cities Rd and Carillion Blvd; then proceeding southerly along Carillion Blvd to Walnut Ave; then proceeding westerly along Walnut Ave to Stockton Blvd; then proceeding southerly along Stockton Blvd and continuing southerly along Highway 99 to Southern Pacific Railroad; then proceeding northeasterly along Southern Pacific Railroad to Marengo Rd; then proceeding northerly along Marengo Rd to Elk Hills Dr; then proceeding westerly along Elk Hills Dr to Walnut Ave; then proceeding northeasterly along Walnut Ave to Park Terrace Dr; then proceeding northerly along Park Terrace Dr to Twin Cities Rd; then proceeding westerly along Twin Cities Rd to the point of beginning.
